Store Process

- G.O.T. Handheld Scanner
- Scan or Enter Primal/Tubes/Scale labels to grind
- Capture info on all trim to grind - including "rework" items
- Scan items into a grind log
- Enter grinder cleaning data
- Transmit files to G.O.T.
- Review daily/weekly reports

How do I get started?

- Client signs a Retailer Participation Agreement
- UNFI Retail Technology sends store setup information to G.O.T
- G.O.T. works directly with Client on setup, shipping handheld scanner & cradle
- G.O.T. notifies UNFI Retail Technology when equipment ships
- UNFI Retail Technology confirms customer is operational

Fees & Terms

- \$100/handheld setup (one-time)
- \$17/week/handheld fee (RT recurring weekly)
- UNFI Billing Services
- 1 year agreement – then annual renewal
- 60-day termination notice (Customer)
- 180-day termination notice (Vendor)
